

PET BOARDING AGREEMENT

This Agreement is between the **Pet Boarding Service** represented by Natalia Lyubimova (hereinafter called the "Kennel") and the **Pet Owner/Representative** whose name and signature appears below (hereinafter called the "Owner"). The term "pet" refers to all pets boarding with the same ownership.

Please read carefully and initial each item:

1. ____ Owner specifically represents that he or she is the owner of the pet, or has been authorized by the Owner of the pet to enter into this Contract as the Owner's agent.
2. ____ Owner agrees to pay the boarding rate for all services and treatments effective on the date the pet checks into the Kennel.
3. ____ Owner specifically represents to Kennel that the pet has not been exposed to rabies or distemper within 30 period prior to boarding.
4. ____ Owner understands that Kennel staff is not a veterinarian or registered veterinary technician. Kennel does not board any pets with medical conditions other than those stable with oral medication.
5. ____ Owner authorizes Kennel to transport pet to veterinary office in case of emergency, or in non-emergency cases where Kennel has contacted Owner or emergency contact/pet's regular veterinarian and been advised of the need for transport.
6. ____ Owner understands that a Trip Fee of **\$25** will be added to bill for each trip Kennel makes to take pet to Owner's veterinarian or to purchase supplies for pet while boarding, and Owner agrees to pay such fee.
7. ____ Owner understands that pets that cannot go into an outdoor play area and must be walked on leash only will be charged an additional fee **\$10 per dog, per day. All charges shall be payable by Owner before pick-up of pet.** Dogs with the following conditions must pay this fee without exception:
 - Jumpers/climbers, diggers or others that can escape,
 - Behavior problems,
 - Bee allergies,
 - Eats gravel/rocks,
 - Unstable on uneven surfaces such as gravel/rock,
 - Dogs shedding parasites (fleas, worms),
 - Females in season.



8. ____ All pets entering Kennel must be clean and flea free. If upon inspection, this is not the case a topical once-a-month flea treatment will be applied at Owner's expense, not to exceed **\$20**. Pets with fleas will not be allowed in an outdoor play area until 24 hours after medical treatment has been applied. Pet must be walked on leash only and will be charged an additional fee **\$10 per pet, per day**.
9. ____ Kennel shall exercise due and reasonable care for each pet while boarding. Under this reasonable care, Owner releases Kennel from, and waives all claims and liability against Kennel for or attributable to, injury or illness of pet.
10. ____ Kennel specifically requires all pets be vaccinated against communicable diseases prior to boarding in accordance with Kennel Vaccination Policy. Owner understands and agrees to abide by Kennel's vaccine policy at all times. Owner agrees to provide all vaccination documentations and medical records. Kennel reserves the right to refuse admittance to any pet that shows signs of illness or that does not meet Kennel vaccine requirements. Despite these precautions, Owner acknowledges that Owner's pet will be in an environment with other pets during boarding, and understands that any pet may harbor and spread a communicable disease. Owner releases Kennel from, and waives all claims and liability against Kennel for, all losses, damages, costs and expenses arising out of or in connection with any communicable disease contracted by Owner's pet during boarding.
11. ____ If the pet becomes ill or if the state of the pet's health otherwise requires attention, Kennel at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the pet up to and including **\$200.00** or _____, **(Owner specify amount)** whichever is greater. If a veterinarian determines that emergency treatment, which exceeds the authorized amount, is needed to save the pet's life or quality of life, and we cannot reach Owner or the Emergency Contact, Kennel may authorize the veterinarian to perform the emergency treatment. **Owner agrees to be responsible for all veterinary costs provided to pet(s)**.
12. ____ Owner agrees that Owner shall be solely responsible for any and all acts and behavior of said pet while it is in the care of Kennel. This includes damage to kennel structure and/or kennel property.
13. ____ Owner understands that Kennel reserves the right to refuse service at its discretion. Kennel does not board pets with behavior problems that are deemed a safety risk for staff, other boarding pets or itself.
14. ____ Owner releases Kennel from, and waives all claims and liability against Kennel for, damage to, or loss of, personal equipment or belongings provided by Owner for pet while the pet is boarded. Owner agrees to limit personal belongings to five items or less per pet boarding. No breakable items are allowed in Kennel (i.e. glass, ceramic bowls, etc.). Items not taken home at check-out will be donated if not picked up within 2 weeks of check out date.
15. ____ If for any reason the pet is not going to be picked up on the scheduled dismissal date, Owner shall contact Kennel to make arrangements to extend the pet's stay and will pay the additional charges based upon the aforesaid daily rate. Every effort will be made to contact Owner or Emergency contact if abandonment becomes an issue. Owner understands that if pet is not picked up within 7 calendar days after the day pet is scheduled for pick up, pet shall be deemed abandoned and Kennel has the right to place pet with a new owner.



16.____ Owner agrees to allow Kennel to use his or her pet's images in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials.

17.____ This Agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives, and assigns of the Owner and Kennel.

18.____ Any controversy or claim arising out of or relation to this Agreement, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Agreement, shall be settled by binding arbitration in accordance with the rules of the American Arbitration Association, and judgement upon the award rendered by the arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

VACCINATION POLICY

Requirements:

For boarding, all dogs must be at least 3 months old and have the following vaccinations:

- Rabies
- Distemper (DHPPC)
- Bordetella Vaccine

For boarding, all cats must be at least 3 months old and have the following vaccinations:

- Rabies
- FVRCP

If pet has not been vaccinated or vaccines have expired, it can't be boarded until 7 days after vaccinations.

Owner has to provide all vaccination documentations and medical records.
